Anti Ragging Committee

1. Introduction

The college has anti ragging committee. The College was reconstituted the Anti Ragging Committee in the academic year 2016-2017. The following instructions are framed to prevent the menace of ragging and foster healthy interpersonal relations among students in the campus of N.J.S.P.M.Adarsh College of Arts, Nijampur-Jaitane. Ragging is strictly forbidden in or outside the college campus. All students shall familiarize themselves with rules/regulations/guidelines on code of conduct, anti-ragging measures and discipline of the College.

2. Objectives

1. To make aware the students of dehumanizing effect of ragging inherent in its perversity.
2. To keep continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
3. To deal promptly and stringently with the noticed incidents of ragging.

3. Functions of Committee

1. To consider the complaints received from the students and conduct enquiry and submit report to the Anti- Ragging Committee along with punishment recommended for the offenders.
2. Oversee the procedure of obtaining undertaking from the students in accordance with the provisions.

3. Conduct activity against ragging menace and orient the students.
4. To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls.
5. To create awareness among the students about Anti ragging.
6. To take all necessary measures for prevention of Ragging inside the Campus.

4. Measures for prohibition of ragging at the institution level as UGC guideline

- 4.1 The institution shall strictly observe the provisions of the Act of the Central Government and the State Governments, if any, or if enacted, considering ragging as a cognizable offence under the law on a par with rape and others atrocities against women and ill- treatment of persons belonging to the SC/ST and prohibiting ragging in all its forms in all institutions.
- 4.2 Ragging in all its forms shall be totally banned in the entire institution, including its departments, constituent units, all its premises (academic , residential, sports, canteen etc) whether located within the campus or outside and in all means of transportation of students whether public or private.
- 4.3 The institution shall take strict action against those found guilty of ragging and or of abetting ragging.

5. Measure for prevention of ragging at the institution level

Before admissions

- In accordance with the direction from UGC, posters and anti ragging slogans were displayed at various places in the college in order to make students aware of the seriousness of ragging as a crime.
- In accordance with the direction from UGC, Information regarding anti ragging is conveyed to the students through the Prospectus.

6. Institutional Authority

The authorities of the institution, particularly the Head of the institution, shall be responsible to ensure that no incident of ragging takes place in the institution.

7. Punishments at the institution level as per UGC guideline

Depending upon the nature and gravity of the offence as established by the Anti Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:

- 7.1 Suspension from attending classes and academic privileges
- 7.2 Withholding/ withdrawing scholarship / fellowship and other benefits
- 7.3 Debarring from appearing in any test/ examination or other evaluation process.
- 7.4 Withholding results.
- 7.5 Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
- 7.6 Suspension/ expulsion from the hostel
- 7.7 Cancellation of admission.
